#### Paths in Partnership, towards Honouring Reconciliation

APLA sponsored Paths in Partnership, towards honouring Reconciliation: A Workshop about Indigenous Peoples in Relationships with Libraries, Archives and Museums, to be held on Monday, October 30<sup>th</sup>, at Pictou Landing First Nation's new Fire Hall. Registration is free of charge. The keynote is Camille Callison of University of Manitoba, CFLA-FCAB, and of the Tahltan Nation. There will be a Knowledge walk with Pictou Landing First Nation Elders and a Presentation on the Mi'kmawey Debert Culture Centre.
