# From the President's Desk

Welcome to the last installment of my "From the President's Desk." It was more difficult to write than the first one!

It has been a busy year and, in hindsight, a quick one. I've learned a lot from this experience and I hope I've done a good job. Thank you for having confidence in me and giving me this amazing opportunity to serve a profession for which I have a deep respect and the Atlantic Provinces in which I've found a happy home. I don't get called an "Upper Canadian" much anymore so I think I'm fitting in.

I think being a librarian is in my blood. Both my parents were high school teachers and my Mom later became a teacher-librarian, even then a rare breed. I experienced her methods first-hand when I attended the high school where she ran the library with an iron fist. A well-dressed, well-spoken, intelligent iron fist who didn't suffer fools of any kind. Ever. She was a force to be reckoned with for students and colleagues alike and she was a great teacher, librarian, colleague, administrator, innovator, mentor, and friend.

I was reminded of this when I received a copy of the speech one of her dear friends and colleagues made at her retirement party 15 years ago. She was a gutsy lady and a human rights pioneer: she sponsored the first library display of adolescent books for gay/lesbian and bisexual kids. She was always willing to share ideas for making the library part of the learning experience of students, a leader and model for women in education in London, a founding member of the Women's Networking Group and even though she never really learned how to use one, made sure her library was one of the first to have computers. She was never at a loss for ideas. As proud as I am of all she accomplished, often in the face of great opposition, my favorite contribution from one of her fellow teachers: "Afraid of Shirley?! Never – as long as you knew what you were doing. Now if you didn't – that's a different story."

We have lost two good people this year; we are better for having known Norman Horrocks and Douglas Lochhead and we are certainly very sad they are gone. They inspired many people and gave a lot to the profession in many different ways. I'm sure many of us admire them and look to their example.

What can we do to show our esteem for such people and make sure libraries and those working in them remain vital parts of our communities? We should always strive for excellence and be willing to learn. We shouldn't be afraid or reluctant to stand up for what we believe in. We should be prepared to educate detractors and nay-sayers, and shed light where there is darkness. We should work together, support each other, and be willing to compromise so long as we don't compromise our principles. And we should always find a way to give back through research, mentoring, teaching, and volunteering.

I'd like to dedicate my last column to my mentor, confidante, supporter, and mother, Shirley Gladwell, with much love and respect and a promise to make her proud as I preside over our conference, On the Edge...in St. John's, NL.

# eBooks Demands Rise as HarperCollins Change Licensing Model: Halifax Public Libraries Monitoring Library Impact

In early March, a major publishing partner of Overdrive changed its lending model for libraries. The new model dictates that any new HarperCollins ebooks can be licensed for only 26 circulations, rather than purchased outright. Once the books have circulated 26 times, an additional license can be purchased in order to maintain access to the title for another 26 circulations. Since this model came into effect, Halifax Public Libraries has not purchased any additional Harper Collins titles.

Debbie LeBel, Collections Development Manager, is currently monitoring the industry and its impact on libraries. She said: "our concern is that this is the start of a growing trend which will steeply impact the cost of providing eBooks to library-goers at a time when demand for this service is exploding." In Halifax, the demand for ebooks rose 260% over the course of the last year.

New North Sydney Library Opens

The Cape Breton Regional Library is happy to announce that the North Sydney Branch reopened its doors at its new location on January 24, 2011. The Wilfred Oram Centennial Library, previously housed in an old stone bank building on Commercial Street, North Sydney, made the move next door to the new North Sydney Heritage and Culture Centre that will also house the North Sydney Historical Museum (including a vintage fire truck!), a Seniors' Centre, and office space. The Library features a bright, modern space with a larger program room, more public computer terminals, and access from the Historical Museum. The Library's new home at the Heritage and Culture Centre will be a community focal point for learning, information, and resources.



New Book Clubs at CBRL

Over the past year, CBRL began to offer Seniors' Book Clubs with the generous support of the New Horizons for Seniors Program. Two clubs began at the main McConnell branch in Sydney in early 2010. Now there is a third club in Sydney and clubs have started at the New Waterford, Sydney Mines, North Sydney, and Louisbourg branches, with two more clubs in Glace Bay.

There can be up to 10 people in each book club. CBRL has obtained 10 copies each of 46 different titles for exclusive use by the clubs. The titles were chosen by a panel of seniors and library staff. Each book club gets four weeks to read their book of choice and then members come together at their library branch to talk about the book. The clubs are proving to be enjoyable social events, great ways to meet other people, and get a chance to hear others' points of view. Juggling the book requests from all

the different clubs around the region and getting them to and from branches on time for each club meeting seems to be the biggest challenge!

The McConnell Library has also started a Book Club for Men, started by Librarian Nick Warren and welcoming men of any age. The titles chosen by this club reflect the interest of the participants, and include some on the seniors' list, but also others available from the library's general collection and personal collections.

## **Eastern Counties Regional Library**

Ms. Griffis was very involved in many of the changes that have occurred over the past few months at ECRL. Her tremendous work ethic, pleasant personality, and the many accomplishments she produced in such a short period of time were much appreciated by library staff and patrons.

# Central Library – Public Art Update

The Halifax Regional Municipality (HRM) sought requests for qualifications (RFQs) between December 7 and January 25, for qualified professional artists and artist-led collaborative groups to participate in a public art design process for the new Halifax Central Library. The first stage of public art solicitation is the RFQ. Ninety-four submissions were received.

On February 28, the public art selection committee met to review the submissions. The selection committee includes:

- Christine Macy Dean, Faculty of Architecture and Planning, Dalhousie School of Architecture
- Robin Metcalfe Curator, Saint Mary's University Art Gallery
- Kim Morgan Artist, Assistant Professor in Sculpture, NSCAD University
- Peter Dykhuis Director/Curator, Dalhousie Art Gallery
- Denis Cunningham- Manager, Communications and Marketing, Halifax Public Libraries

Six artists have been selected to move onto the next stage of competition, including:

- Dan Corson USA
- Garry Neill Kennedy and Cathy Busby CAN
- George Legrady CAN (living and working in the United States of America)
- Jill Anholt CAN
- Realities United GER
- Rodney Latourelle CAN (living and working in Germany)

## Each submission was assessed on:

- the artist's or collective's capacity to work collaboratively with the project team (architects, etc.)
- the strength of their past work and peer recognition
- the nature of their approach to this project in relation to the project itself (the design of the building, the functional use of the space, and the community relationship to the library)

Shortlisted artists will now work in consultation with project architects and municipal staff to produce a detailed design for integrated public artwork to be included in the construction of the Halifax Central Library.

## Art Attack - No Holds Barred Arts & Crafts

Halifax Public Libraries and its community partners, Visual Arts Nova Scotia (VANS) and the Nova Scotia Centre for Craft and Design (NSCCD), are encouraging HRM residents to get crafty with the launch of Art Attack – No Holds Barred Arts & Crafts.

Art Attack, a four-week series of arts and crafts programming, launched Monday, March 21, and is aimed at promoting local artistry and crafting and at providing an environment where library goers may unleash their own creativity.


"Working closely with our community partners on this project has enabled Halifax Public Libraries to provide unique opportunities for all HRM residents to learn more about the wonderful work being produced by our local arts and crafts community and to have a chance to learn new creative skills," said Heather MacKenzie, Regional Manager for Arts and Culture programming.

"Our libraries also have extensive collections for borrowing to support learning in all areas of arts and crafts. We hope regular library-goers and new customers will visit their local branch during this exciting program series and discover their inner artist," added Heather.



Programs will cover many forms of arts and crafts — from painting to jewelry making, knitting to digital imaging and more. There are some programs which are hands-on in nature and others will provide customers with a demonstration by an artist. "Meet the Maker" programs will provide an opportunity to see works in development and to meet the artist behind the craft. Selected branches will also provide library visitors an opportunity to create their own piece for an "ink quilt" that will be displayed later in the branch.

Halifax Public Libraries is hosting an artist-in-residence at the Captain William Spry Public Library from March 23 to April 20. Local textile artist, Pat Loucks, will present workshops on making art with cloth in different ways, such as tie-dyeing, waxing, painting, inkjet printing, stitching, and weaving. Pat will also have a workspace to create her own work during the residency.





Construction is underway to create a new computer space at Dartmouth North Public Library. The Evolutions Room in the Dartmouth North Community Centre (DNCC) will now become part of the library. Additional computers will be added to the library, increasing the total number of available computers to 19, including one assistive-technology workstation with an adjustable table for wheelchair access. The room that currently houses the DNCC CAP site will become a bookable meeting room for the community.

Community Recreation Services (CRS) now manages and operates the DNCC and computer labs are not a program offered by CRS. "Halifax Public Libraries works collaboratively with a range of partners to provide services to the community and we offer computer access programs in 14 branches," said Darla Murzerall, Branch Manager of the Dartmouth North Library.

To ensure that members of the Dartmouth North community continue to have free computer access, the library and CRS have developed an agreement that will see this popular computer access program continue as part the computer and Internet services offered by the library.

"In this case, there was a unique opportunity for the library to work with the centre, and to ensure continuation of a needed service to the community," adds Darla.

The PEI Public Library Service Library Skills Development Certificate Program will be offering an exciting new workshop this spring. This is the fifth workshop to be offered in the eight module certificate program, designed for front line customer service staff. In May we are pleased to offer Community Engagement, a full day workshop presented by a team from Halifax

\_Public Libraries.

The PLS will also soon be engaged with Islanders via Digital Media Downloads on OverDrive. A startup collection of 2000 audio and ebooks in all genres has been selected to ensure there is something for everyone to enjoy.

Our March break program, Read Around the House, was very successful this year. Registration increased by more than 100% and the number of books read jumped by almost 50%.

Since January 2011 all branches have been holding weekly storytimes using the template developed by the Newfoundland and Labrador Public Libraries. The template allows branch staff to draw on common resources and to ensure that families across the Island have access to a planned program using one or more of the six essential early learning skills.

SIM Welcomes Dr. Ann Curry as Researcher-in-Residence

The School of Information Management (SIM) was very pleased to have Dr. Ann Curry join us as a Researcher-in-Residence for the month of March 2011. Dr. Curry holds a BLS (AB), an MLS (UBC), and a PhD in Information Studies from the University of Sheffield. Dr. Curry is past director of the School of Library and Information Studies, University of Alberta, and is currently on study leave from the School. Dr. Curry had a lengthy career as a public librarian before joining academe, which resulted in her life-long advocacy of the public library as a key information forum and intellectual freedom bastion.





Dr. Curry's library career began in 1969 when she was assigned to teach English and math at a very impoverished Chinese school in rural Malaysia. There were no public or school libraries in the entire northern state near the Thai border. Concerned about her students' lack of access to the resources they needed, Dr. Curry started a small school library in an empty office, with books sent by sea from her parents in Canada and with books gathered from the local Peace Corps volunteers.

Dr. Curry is currently completing research on the phenomenon of the "heckler's veto," the threatened or actual disruption of a speaker in the public arena that results in the cancellation or truncation of a public speech. The heckler's veto has been exercised on Canadian and American university campuses and in public libraries many times over the past twenty years, always accompanied by controversy. The veto by threat of violence from protestors or by the noise of actually shouting down the speaker is considered by some to be a right of free speech under the Canadian Charter, while others consider the veto an undemocratic act of censorship. Dr. Curry is analyzing all sides of this complex issue under American and Canadian law and as played out in public forums.

IM Public Lectures at SIM

We've had a diverse group of guests for our Public lecture series at SIM. Below are some highlights:

From Just-in-Case to Just-in-Time: The Changing Models for Information Resources Management and Development by Joyline Makani, Management and Economics Librarian, Dalhousie University

#### APLA BULLETIN

In today's economy, faced with increased pressure to reduce costs, information resources vendors, and publishers are more receptive to the idea that just-in-time (JIT) business and service models could be beneficial to their bottom-line. JIT is a management philosophy that focuses on the production and inventory system ensuring that supplies arrive just as they are needed. Consequently the mounting pressure on vendors' margins and the increasing adoption of JIT concepts as ways to reduce costs has resulted in new selection and acquisition models being pushed into the information manager's work processes, specifically collection management and development processes. For librarians/information managers, the question remains: is JIT the right prescription to the effective building and maintaining of library collections, i.e., does JIT enable lean and efficient collection development processes?



Joyline Makani has worked as the Management and Economics Librarian at Dalhousie University for over ten years. As a subject specialist, her primary areas of responsibility with regards to collection management and development include business, commerce, economics, information management, and public administration. She also teaches graduate and undergraduate courses in the Faculty of Management. She holds MLIS and MBA degrees from Dalhousie University and is currently a PhD candidate in Knowledge Management.

The Freedom to Read in Canada: Is the Door Opening or Closing? by Ann Curry, School of Library and Information Studies, University of Alberta

An analysis of censorship incidents in Canada and abroad within the last 12 months reveals a disturbing trail of restricted access to information. Dr. Curry will discuss the freedom to read in its broadest context and how this freedom philosophy has been implemented or incinerated in various situations.

Ann Curry is a professor and past director at the School of Library and Information Studies, University of Alberta in Edmonton. Previously, she taught at the University of British Columbia in Vancouver for 18 years and worked for 19 years in special, college, and public libraries in Canada and Australia. She is an award-winning teacher, and speaks frequently at conferences regarding intellectual freedom, library architecture, and the role of public libraries.



Help! My Mum's on Facebook: Combating the Lowest Common Denominator Culture in Online Social Networks by Bernie Hogan, Research Fellow, Oxford Internet Institute

Traditional interfaces to social network sites (such as Facebook, Twitter, and MySpace) offer users few cues about the underlying friendship structure. Diverse weak ties such as neighbours, parents, workmates, family, high school chums, church mates, and sports teams are represented in one-dimensional lists of 'friends'. These lists make it difficult to work with

are represented in one-dimensional lists of 'friends'. These lists make it difficult to work with information that requires situational norms (such as complaining about a boss, but still wanting to be employed, expressions of religious faith without offending non-believers). This talk gave an overview of past literature as well as interviews conducted in June of 2010 that

suggest first a trend towards the lowest common denominator of possible discussion topics (reducing this potential public sphere to tourist pictures, baby photos, and today's lunch menu) as emerging alternative mechanisms used to resist or combat this lowest common denominator.



Bernie Hogan is a Research Fellow at the Oxford Internet Institute. He specializes in novel methods for online data capture and analysis, especially via social media. Recent work has focused on the capture analysis of Facebook networks, particularly through his application namegenweb, which downloads a social network for visualization in network programs such as NodeXL. Past work included an online audit study of racism on Craigslist, pen and paper methods for visualizing social networks, the analysis of profile photos, and techniques for online surveys of spouses and partners. Bernie received his dissertation from the University of Toronto in 2009 under Barry Wellman. This thesis won the Dordick Award for Best Dissertation from the Communication and Technology section of the International Communication Association.

# **Atlantic Provinces Library Association Meeting Rules**

- 1. All Personal, Honorary Life, Life, and Institutional Members may participate in discussions at General Meetings. Nonmembers may speak by general consent of the Members or by majority vote of the Members present and voting.
- 2. Persons seeking recognition from the Presiding Officer shall identify themselves for the record, giving their names, library or other affiliation, and whether Members or nonmembers.
- 3. All categories of Members as given above may vote whether present in person or by proxy in accordance with the Articles of Association.
- 4. Debate shall be limited to five minutes for each speaker; no speaker may have the floor twice on the same question until all who wish to speak have spoken.
- 5. Resolutions at ordinary general meetings shall be submitted to the Resolutions Committee in either of the official languages. Resolutions shall be presented to the ordinary general meeting in English; if asked for, a free translation of resolutions into French will be given orally from the floor by a French-speaking member of the committee; and Resolutions shall be printed in their final form in the APLA Bulletin in both English and French. Resolutions shall be framed only in connection with contentious matters or questions of policy. The presiding officer shall protect the meeting from obviously frivolous or dilatory motions by refusing to recognize them.
- 6. All motions and amendments from the floor shall be written by the makers and submitted to the Secretary. Discussion will not begin until they have been read or displayed to the Membership.
- 7. At the beginning of each session of the meeting the Presiding Officer will announce the agenda and rule on proposed additions. After the agenda has been adopted by the members present, it can be departed from only by general consent or by a two-thirds vote.

One of our first duties was to write 2 letters to then-Minister Tony Clement regarding the axing of the Census Long Form and amendments to Copyright legislation. The government decided not to reinstate the Census Long Form and is proceeding with its National Household Survey. I kept in touch with a contact at Statistics Canada and offered APLA's assistance to ensure as many of the new surveys are filled out as possible so the government would get the most accurate information about Canadians. Bill C-32, the amendment to Copyright legislation, died when the Conservative government fell in March. And after being passed unanimously in the House of Commons, An Act to Amend the Canada Post Corporation Act (library materials) C-509 was stranded in the Senate. Once the election is decided the latter 2 Bills will have to start their journey all over again and APLA will be front and centre and ready to be heard and to help.

We also sent a letter to the NLPL in support of the NLLA's letter regarding the recent posting for a Director of Regional Services. It was advertised internally with an MLIS being a requirement, but when it was posted publicly, that requirement was gone. As of this moment (April), APLA has not had a response from John Tetford and neither has the NLLA.

Games @ the Library was again a success, but our winner has been out of the country. Hopefully we will be able to name them by the time the OGM rolls around.

We had 2 requests for GAF grants this year from Information Without Borders and Hackmatack. They are both worthy events and important to the library community in the Atlantic Provinces, and the student-organized IWB is always well done. APLA was able to contribute funds for both events.

The VP/President Elect sits on several committees and convenes several others including the Committee on Committees and Interest Groups and the Carin Alma E Somers Scholarship Trust Committee. The VP/President Elect also participates in the deliberations of The Partnership of Provincial and Territorial Library Associations.

## The Partnership

Two meetings of The Partnership are hosted annually by the Ontario Library Association, one in August (with expenses including travel fully funded by OLA) and another in winter. I attended both meetings. The Partnership's stated mission is to generate revenues to support the work of library associations across the country by offering member services and programs that are jointly developed, supported and promoted by the member associations. Major initiatives include the Job Board, the Education Institute and *The Partnership Journal*. APLA derives a small income from the Job Board and El. Another important benefit of The Partnership is the information-sharing opportunity it provides to associations as we face similar challenges and strive to offer value to our members.

The Partnership has been following CLA developments closely. CLA Executive Director Kelly Moore attended both meetings to answer questions about the draft CLA Strategic Plan and next steps for the national association. Another initiative of The Partnership has been a pilot Certification Program the objective of which is to promote continuing education amongst library workers. A number of actions remain to be undertaken before a national roll out of the program can take place.

#### Carin Alma E. Somers Scholarship Trust Committee

I chaired the committee composed of the VP/President Elect and the four provincial vice presidents. Eight applicants for the scholarship were considered. The winner was decided unanimously and will be announced at the APLA Ordinary General Meeting Part 1.

- (2) 50 percent may be used to maintain the health of the APLA Memorial Awards Fund and/or the First Timers Grant Fund and/or general revenue with the division to be based on the recommendation of the Finance Committee and approval of the Executive.

# Standing Order 6.04

A motion will be presented at the 2011 APLA Ordinary General Meeting in St. John's to adopt a revised terms of reference for **Standing Order 6.04: Continuing Education Committee**. Please take note of the rationale and the proposed new terms in preparation for voting at the OGM.

Rationale: In the last several years, APLA has had both an Interest Group and a Standing Committee focused on continuing education. As we have been unsuccessful this year in recruiting a convener for the Interest Group, and given the overlap in mission between the Committee and the interest group, the Executive moved at its Spring meeting to dissolve the Interest Group and enhance the terms of reference for the Standing Committee. Continuing Education is one of the most important member services APLA provides and this change is intended to strengthen our delivery mechanisms.

### **Proposed Revision:**

#### Standing Order 6.04: Continuing Education Committee

**Membership:** The Committee shall include the Chair, the APLA President and Vice President/President Elect, as well as a minimum of three additional members. These members shall represent various types of libraries. Members may serve up to three years.

#### Terms of reference:

- 1. To identify continuing education needs and opportunities within the region;
- 2. To develop continuing education content in response to identified needs;
- 3. To liaise with the Partnership's National Continuing Education Committee and collaborate in the joint development of high quality continuing education programs;
- 4. To work with the Partnership's Education Institute in the planning of content offerings, including Atlantic VOLUME 74

- 5. To publicize continuing education opportunities and promote the Partnership's Education Institute through the APLA website, Bulletin and listserv;
- 6. To solicit articles on the subject of continuing education for the APLA Bulletin; and

# **Financial Examiner's Report**

To the members of the Atlantic Provinces Library Association

I have examined for integrity and accuracy the financial records of the Atlantic Provinces Library Association as at 31 March, 2011, including the statements of operations, functional expenses, changes in fund balances and changes in financial position for the year then ended. My examination was conducted in accordance with generally accepted auditing standards and, accordingly, included such tests and procedures as I considered necessary in the circumstances. In preparation for my review of the Association's records I met and corresponded with the Treasurer to receive the necessary documents and discuss certain points.

In my opinion, the Statement of Revenues and Expenditures and Balance Statement represent fairly the financial position of the organization and its investments as at 31 March, 2011, and the results of its operations and the changes in its financial position for the year then ended in accordance with the notes to the Statement applied on a basis consistent with that of preceding years. As of that date, the aggregate of assets is \$78,898.29 and the Association's equity is \$78,570.19.

Included in my examination were the current accounts of the Association, its investment accounts, and the Carin Alma E. Somers Scholarship Fund. With respect to reports of previous years, a subsequent amount (\$132.21) could still be considered for repayment from the Somers Fund; however, since a similar charge (\$171.76) for 2010 was paid by the Somers Fund itself, given the sum involved, the Association may choose to cancel this former debt. An additional amount (\$159.64) was paid by the Association for tax preparation and tax owing for 2010. As long as these amounts continue at a modest level, the Association may prefer to continue to absorb those expenses. The current value of the Somers Fund remains at \$76,185.51.

I have also examined the financial records of the APLA Memorial Awards Trust Fund and, in my opinion, the Statement of Revenues and Expenditures and Balance Statement represent fairly the financial position of the Trust Fund as at 31 December, 2010. Current investments are valued at \$20,000 and deposits of \$13,490.05 are in a current account. No award was made in 2010.

# Treasurer's Report

As reported last year, investments in money market funds are making a slow recovery. Most of our GICs mature in 2011 and are being renewed at the best rate available. The Conference 2010 Committee is to be congratulated for achieving a significant surplus - \$13,196.47. This surplus is offset by no revenue from Bulletin advertisement. Membership revenue is also down slightly from budget projections, but Membership Chair Ann Smith and the provincial VPs should be commended for a concerted effort to gather institutional memberships, which rose by almost 1/3 over last fiscal year. This year has also seen the addition of two new membership partnerships. We now offer combined memberships with NSLA, NSALT, and APLNB. Revenues less expenses show a net balance of \$10,749.02

# Vice-President, Membership Report

## **Summary of Membership Numbers**

I am delighted to report that our overall membership numbers are healthy at 379 (see Table 1, page 2). We have 97 new memberships this year (see Table 2, page 2). The majority of our members are personal members as is usual (see Table 3, page 2). The distribution of memberships by region is similar to previous years with Nova Scotia and New Brunswick containing the majority of members followed by Newfoundland and Prince Edward Island (see Table 4, page 2). Newfoundland is doing particularly well this year which in part is due to the location of our conference. The majority of our members remain professional librarians, with para-professionals and students making up a significant minority of members.

#### **Institutional Memberships**

This year the Membership Committee had a successful drive on institutional memberships. There has been an increase in institutional membership from 17 to 27 (see Table 6, page 3). The last time we had this many institutional memberships was in 2005: six years ago! There have been increases across all types of institutional memberships and from all the provinces.

#### Survey of Regional, National, and Territorial Library Associations

As VP Membership I thought it was time we reviewed the membership numbers, categories, fees, and benefits offered by some of the other regional, as well as national and territorial, library associations. As a result of the survey it is clear that APLA membership benefits are similar and comparable to other associations. In terms of overall membership numbers we are doing well. Some of the other associations are moving toward one day conferences because of much lower membership numbers. It is clear that our fees remain extremely reasonable. The Membership Committee will bring forward some potential changes to the types of institutional memberships and fee structure of institutional memberships in the 2011/2012 APLA year. These will be presented to the membership in 2012.

#### Joint Memberships with the Newfoundland and Labrador Library Association (NLLA)

Bill Slauenwhite and I are currently working with NLLA on a joint membership proposal. The joint memberships are one of our fastest growing membership categories.

## **Administrative Changes**

I asked the fabulous Larry Tweed to increase the number of EasyAsk Reports we produce and to change the structure of these reports to include the "grace period". The "grace period" means members whose memberships expired up to a maximum of three months previously. As members have full voting rights in the "grace period", the membership reports and data should reflect this.

Database maintenance is ongoing. Although our reports only contain active members, there were some very old records (96) in the database and I asked Larry to remove these. Again, we have modified the membership database fields to increase the accuracy and ease with which membership information can be retrieved.

# **The Membership Committee**

The Membership Committee has been busy again this year. This year Sarah Gladwell, Sharon Haley-Mancini, Sarah Kilfoil, Tina Murphy, Trina O'Brien Leggott, Bill Slauenwhite, and Jocelyne Thompson were enthusiastic, hard-working, and tenacious. The results are reflected in those membership numbers. Thank-you!

#### 2011 Goals

# Dalhousie University, School of Information Management Update

## **Program Updates**

The Master of Library and Information Studies (MLIS) welcomed 53 new students in 2011; applications for the 2011/2012 academic year are very healthy and are significantly higher than t they were this time last year (May 2010). The Master of Information Management (MIM) program saw its first graduants in the Fall Convocation: three students received their Graduate Diploma and are continuing their studies towards the final MIM degree. We are currently working to expand our marketing plan to reach out to targeted industry areas, including banking, insurance and health. The Knowledge Management major in the Bachelor of Management is proving to be very successful to the point where extra course sections needed to be added. SIM faculty members are actively involved in teaching courses in the MLIS, MIM, and Bachelor of Management programs.

SIM is preparing for the renewal of accreditation of the MLIS program (2012-2019). A site visit will take place in October 2012. We will be preparing our program review in anticipation of a successful outcome.

### **Faculty Updates**

Dr. Fiona Black has been awarded a Nominated Research Fellowship at the Institute for Advanced Studies in the Humanities (IASH) at the University of Edinburgh, Scotland, where she is working on the SSHRC-funded project "Investigating Complexity in Information Studies: The Example of Print Culture and Geographic Information Systems." Dr. Fiona Black is part of a Dalhousie team to receive an award of \$500,000 from the T. K. Foundation to study the question of piracy from the perspective of its economic, social, legal, political, governance, administrative and security/operational aspects. Key to this endeavor is the involvement of representatives from across the university in the areas of international law, legal enforcement, marine security, marine transportation and commerce, information and knowledge management, international development, marine management, policy and governance.

Dr. Vivian Howard has been awarded the 2010/11 Eileen Wallace Fellowship from the University of New Brunswick. Among other criteria, the successful applicant must demonstrate scholarly knowledge in the field of children's literature. Dr. Vivian Howard has been promoted to the rank of Associate Professor, with tenure.

Jackie MacDonald, an adjunct faculty member, successfully defended her PhD dissertation (University of Sheffield): "The Information Sharing Behaviour of Health Service Managers: A Three-Part Study."

Dr. Ann Curry (University of Alberta) was a researcher-in-residence during the Winter term. Dr. Curry's research focuses on phenomenon of the "heckler's veto," the threatened or actual disruption of a speaker in the public arena that results in the cancellation or truncation of a public speech. The heckler's veto has been exercised on Canadian and American university campuses and in public libraries many times over the past twenty years, always accompanied by controversy.

Dr. Vivian Howard has been working on the Sea Stacks (seastacks.ca) research project. Sea Stacks is an authoritative, webbased resource for teachers, librarians, researchers, youth, and parents that features information on and about Atlantic Canadian books, authors and illustrators for children and young adults. When completed, the site will include comprehensive annotated bibliographies of primary texts, author and illustrator profiles, videotaped interviews, analysis, and criticism.

Dr. Anatoliy Gruzd's research into the use of twitter feeds during the Canada Winter Games and the Federal Election has generated much interest in the news media.

Dr. Louise Spiteri has been approached by OCLC (Online Computer Library Center), which is the world's largest computer library service and research organization dedicated to the public purposes of furthering access to the world's information and reducing the rate of rise of library costs, to conduct research on the WorldCat catalogue. This project will explore the use of social features (e.g., tagging, reviews, and user ratings) in WorldCat, which is an extension of Dr. Spiteri's ongoing and ground-breaking research into the use of such features in social discovery systems.

Dr. Bertrum MacDonald has been appointed to the Board of Trustees of the Public Archives of Nova Scotia. Dr. Louise Spiteri was elected to the Board of Directors (Director of External Affairs) of the American Society for Library and Information Science Education, and has been chosen to serve on the American Library Association's Committee on Accreditation, which is the body that accredits the MLIS program. Dr. Spiteri will undergo training in 2012.

#### Student updates

In conjunction with our student association, we launched the 2010/2011 professional partnership program. The program pairs an MLIS student with a professional mentor in the information management professions. This year saw the largest number of participating mentors in the program's history.

There will be four presentations from MLIS students at the annual conference of the Canadian Library Association in May.
