Terms of Employment: 1987-88 Survey

is generally realized that the majority of librarians working in Atlantic Canada do so at salary rates far lower than our counterparts in central and western Canada.

Terms of employment governing librarians within the Atlantic region also vary. A survey of academic librarians published in the March/ April, 1987 issue of the APLA Bulletin showed a gap of up to \$10,000 in some ranks between New Brunswick and Nova Scotia salaries. This year, the survey has been expanded to include the other groups of public sector librarians — those working in public, school and provincial and federal government. Findings will be published in the APLA Bulletin beginning with information on academic librarians in this issue. Analysis and discussion will be presented at the conclusion of the series.

Academic Librarians

In this part of the survey, questionnaires were sent to the University Librarians of twelve Atlantic universities. All libraries have more than one professional librarian on staff. Responses were received for all questionnaires mailed. Thank you to all respondents.

Very little change took place in the terms of employment governing Atlantic Provinces' academic librarians between 1986-87 and 1987-88, as revealed in the collective agreements. This year's questionnaire used was basically the same as last year's with the addition of the questions "Is a collective agreement or contract in place?" and "Which

other groups on campus are in the same bargaining unit?"

Please see table. Information not from current contracts appears in square brackets. Information on the University of Moncton was taken from a contract which expired June 30, 1987. At the time of writing, librarians at TUNS were "on strike". Rather than reproduce the information from last year's table (which was from the 1985-86 agreement and already one year out of date) the column has been left blank - we hope to have the information for the next issue. "****" indicates information not stated on either the contract (or equivalent document) or the returned questionnaire. "N/A" indicates information that was not considered applicable by the respondents.


Other business at the executive meeting in February included:

It was a busy executive meeting and has been a busy and interesting year for me. I thank all the members for giving me the opportunity to be president and the executive members and committee convenors in particular for all their work this year. I am sure the association will join with me in extending special thanks to those members of the executive who are finishing their terms this year: Richard Ellis, George Beckett, Jerry Miner, Susan Collins and Suzanne Sexty.

The Health Sciences Library of Memorial University of Newfoundland is seeking applicants for the full time, tenure track position of Librarian (Systems and Planning).

This position reports directly to the Health Sciences Librarian. Duties and Responsibilities

The major responsibility of this position is to act as an innovator and resource person in implementing computer based systems in the Health Sciences Library. The Library is currently investigating the feasibility of a CD ROM based public access catalogue and the successful applicant will be heavily involved with the introduction and implementation of this system. As directed by the Health Sciences Librarian, the successful applicant will also be responsible for conducting preliminary investigations into matters chiefly concerning the Library's present physical environment and future requirements. Such investigations will include the formulation of projections and recommendations for consideration by the Health Sciences Librarian and the Library's Administrative Group.

As a member of the Library's professional staff, the successful applicant will assist in the provision of information services to the Library's clientele (including on line searching) and will participate in the Library's collection development programme.

Benefits

Rank and salary will be based on qualifications and experience. The standard academic fringe benefits are available including eligibility for sabbatical and study leaves. Tenure track positions include a generous moving allowance.

Qualifications

An MLS or BLS from an accredited programme is required. Experience in or familiarity with the identification and implementation of computer based systems in a library setting is a prerequisite for this position. Good communication skills both oral and written are mandatory. Previous experience searching MEDLARS and DIALOG or BRS systems is required. Other desireable characteristics include: experience in providing general information services to health care personnel; knowledge of the strategic planning process; and familiarity with bibliographic instruction and/or end user training. President

My major activity of the year was letter writing, and trying to learn enough to write sensible letters, on postal subsidies, pornography and copyright. Only time will tell if our letters had any effect, but we certainly contributed to the effort to make the voice of libraries heard on these issues.

CLA provided some useful information and direction in these lobbying efforts and I tried to pass on some of it to other people and associations in our region. The executive looked at ways to improve liaison with other library associations in the region and has decided to try to arrange exchanges of the *Bulletin* for other associations' newsletters for a start.

Internal matters that the executive considered this year included transferring the mailing list from the Bedford Institute of Oceanography computer to our own personal computer; ensuring that our constitution is registered legally; changing the *Bulletin* management structure; reviewing guidelines for other publications and adopting guidelines for speakers expenses. Details of these activities have been reported in the *Bulletin* or are covered in the reports of the relevant committees.

I think it was a good and productive year in most ways. My only concern is that there was little APLA — sponsored activity in the form of workshops or other projects funded by the General Activities Fund. I hope this is just a temporary situation, perhaps related to preoccupation with the CLA conference, and that we return to our usual level of activity in the future.

Vice President Prince Edward Island

The past year was generally a positive one for the libraries on P.E.I.

The P.E.I. Department of Education, which is indirectly responsible for school libraries and directly responsible for public libraries through the P.E.I. Provincial Library, approved a five year plan which will result in more money being allocated to both books and salaries for libraries. The public library service also saw its book budgets increased significantly. Additional microcomputers were installed in the Government Services Library and Confederation Centre Public Library.

In the School Library field, the Department of Education funded five additional school library positions outside the pupil-teacher ratio. The Department has also begun to develop a Policy Statement on School Libraries as well as guidelines for school libraries.

A one-day workshop on Resource Sharing was organized by the National Library at the University of Prince Edward Island. All library segments on P.E.I. participated in this conference.

The Library at Holland College ceased to be a circulating library and became a reference library only. This change will be evaluated this fall.

Finally, the annual APLA conference for 1989 will be held in Charlottetown. Joyce Gaudet, Librarian at the Veteran's Affairs Canada Library in Charlottetown has agreed to be convener for the local Arrangement Committee and Priscilla Ykelenstam, Librarian at the Provincial Library, has agreed to be convener of the Programme Committee.

Regional libraries

New Brunswick Library Service

The New Brunswick Library Service has begun a study to determine requirements for automating the provincial computer catalogue and the functions of the public library system. In June 1987, the Department of Tourism, Recreation and Heritage had set up a committee to review existing guidelines and establish new standards for the public library system. of the province. During the fiscal year 1987-88, four new libraries will be opened in the communities of Newcastle, Bas Caraquet, Lamèque and Petit Rocher.

UNB (Fredericton) Harriet Irving Library

The library has recently developed specifications for an automated circulation system. These are now being reviewed by the computing centre in preparation for programming and implementation. Andy Pope, head of the Education Resource Centre, working full time on the project of three months, was the one largely responsible for developing the specifications.

There has been a three month trial in which the National Library and CISTI have delivered interlibrary loans via priority post to several New Brunswick libraries. UNB has acted as distributing centre for the participants.

UNB is now downloading records from both UTLAS and BIBLIOFILE directly into PHOENIX.

UNB (Saint John)

Ward Chipman Library
The Ward Chipman Library was able to take advantage of the Challenge '87 program to further its recon project for its computer catalogue. Approximately 80% of holdings are now on the PHOENIX system which was developed by UNB Fredericton library and the UNB computing centre. Catalogues at the various UNB Fredericton libraries can be searched at the UNB Saint John library terminals.

Mount Allison Ralph Pickard Bell Library

Tom Eadie has been appointed the new University Librarian.

The university archives have received a grant from the National Archives / Canadian Council of Archives "Arrangement and Description Backlog Reduction Programme". Under this programme, costs are shared for the preparation of inventories and copies of the finding aid are then placed at the National Archives in Ottawa.

Université de Moncton Bibliothèque Champlain

Université de Moncton Cours d'Aide Bibliothècaire

Cours et ateliers sont presentés par des personnes ressources choisies a partir de leurs connaissances du sujet. Cette formation permettra d'abord aux personnes qui travaillent déjà dans une bibliothèque scolaire, publique ou specialisée de faire l'acquisition de nouvelles connaissances et d'améliorer leurs habilites. Les personnes nouvelles dans le domaine de la bibliothèque mais qui aimeraient y travailler pourront aussi être formees. La durée totale du programme sera de 110 heures et ces cours ne seront pas credités. Le Centre universitaire Saint Louis Maillet projette d'offrir ce cours en Septembre 1988.

Vice President Newfoundland

The past year has been one of re evaluation of library services in Newfoundland and Labrador. New libraries have begun, notably in the academic library field, but there has also been reassessment of existing library services. The use of computer systems to provide cost effective service to library patrons has been increasingly contemplated by many libraries.

School Libraries

A major development for school libraries was a symposium on school libraries held at Memorial University of Newfoundland (MUN) in October. Sponsored by interested organizations such as the Newfoundland Department of Education, MUN and the Educational Media Council of the Newfoundland Teachers Association, the symposium examined the situation and needs of school libraries in Newfoundland and Labrador.

Following soon after the symposium was the creation by the Department of Education of a committee to draft a provincial school library policy and policy implementation plan. The committee is chaired by Jean Brown of the MUN Faculty of Education and it is hoped to have a draft document ready for discussion by September 1988.

These developments follow several years of work by members of the Educational Media Council of the NTA to develop guidelines for school libraries in the province. At long last there seems to be some official recognition of the weaknesses in the library resources available in the schools of the province.

Special Libraries

There has been a noticeable increase in the use of automated systems to support operations in special libraries in the province. Computerized database searching has been joined by automated cataloguing and circulation systems to support library technical services. The most common system is INMAGIC running on an IBM PC compatible microcomputer.

Improved service of another kind has developed as the result of an agreement between the federal government Department of Fisheries and Oceans Regional Library in St. John's and the provincial Department of Fisheries. The D.F.O. Regional Library provides library services such as ILL, computer searching and telephone reference to the provincial department.

Archives

This was another active year for the Association of Newfoundland and Labrador Archivists. In November the Association sponsored the visit of Harold Holland, conservator of the Provincial Archives of New Brunswick, to St. John's to consult on a number of paper conservation concerns. Arising out of the concerns about paper conservation which are jointly shared by archives and libraries, the Memorial University Library and the Newfoundland Public Library Service have agreed to jointly support a preservation technician position.

Several archival groups in the province are also examining the possibility of using a combination of the LASER-QUEST microcomputer cataloguing system for data entry and the SPIRES mainframe database management system for retrieval in order to create databases of archival records. The archival records would be prepared using the MARC Archival Manuscript Control format

Public Libraries

Public libraries in the province faced a financially difficult year in 1986-87. In spite of this, two libraries were opened, most notably the Gander Regional Library which officially opened its new building in September.

In order to provide the best service possible across the province a review and reallocation of service hours in all libraries was conducted. The review was based upon surveys of library usage which considered factors such as in house use, circulation statistics and program attendance.

In the labour relations field, part time staff in rural libraries have joined CUPE and are now administered under the CUPE contract. Management positions in the Public Library Service have been reclassified according to the Hayes Classification scheme.

Academic Libraries

At Memorial University Library, 1987-88 has been a busy year. A serials usage study was conducted to evaluate the periodical collection. This study resulted in the cancellation of approximately 400 journals. The serials usage study is continuing and more periodical cancellations are expected.

The MUN Library is conducting an intensive evaluation of commercially available microcomputer/CD ROM public catalogue systems with the hope of replacing the current microcatalogue with such a system in the next year or so. A LASERQUEST CD ROM cataloguing system has been acquired and development is underway for utilizing the SPIRES (Stanford Public Information Retrieval System) for managing local bibliographic databases.

Librarians at MUN have been included in the collective bargaining unit formed by the recently certified MUN Faculty Association. Negotiation of a first contract has recently begun.

Another significant development this year has been the creation of several new libraries for campuses of the newly created community college library system. Libraries have been created at Corner Brook, Grand Falls and Lewisporte. Planning is underway for creation of more libraries as the community college system becomes more established.

Pat Rahal of the Cabot Institute of Applied Arts and Technology acted as a consultant to the Department of Career Development and Advanced Studies to plan the development of the new library system. There are hopes of creating a centralized technical processing system for the community college libraries but this is not yet certain. The development

of the community college libraries is an ongoing struggle as the need remains to convince politicians and college administrators of the value of quality library service.

Associations and Workshops

The Newfoundland Library Association has changed its constitution in order to hold Newfoundland Library Week concurrently in the spring with National Book Festival Week. NLA has created a Microcomputer Interest Group which has been useful as a means for interested librarians to share experiences and information.

A group of over forty people attended the CLA Seminar "Technology Update" in November in St. John's. The seminar was warmly received and served to highlight the increasing interest in automated systems in libraries in the province.

Library Education

The Library Studies Certificate program offered by Memorial University's Extension Services Division has been successful. Oriented towards people outside of the St. John's area, the program has met with positive acceptance from the library community and is currently developing more courses.



During the year there was also a significant amount of correspondence which was conducted concerning Bill C-54 (pornography) and Bill C-60 (copyright). This correspondence was sent on behalf of the President to the appropriate provincial and federal legislators.

Finance Committee

The Finance Committee discussed two matters in addition to the budget this year. Some consideration was given to raising the amount of the APLA prize for the outstanding library school graduate. It was decided that more recognition should be given to the winners by listing them in the proceedings, interviewing for the *Bulletin*, giving them certificates and, if possible, displaying a list of winners at the library school. It was felt that the amount of the award was comparable to other similar prizes and need not be increased.

The following guidelines were proposed by the committee and approved by the executive at the February 1988 meeting.

Guidelines for the Expenses of Speakers at Conferences and Workshops:

These are basic guidelines and are subject to negotiation depending on individual circumstances and the financial position of the association. An honorarium may be paid in addition to, or in lieu of, expenses. If expenses are to be paid, transportation, accommodation and meals should be covered as follows:

1.Transportation - no more than regular economy air fare, bookings to be made by APLA, plus ground transportation to and from airports and other ground transportation as required.

2.Hotel - one night's accommodation at a hotel chosen by the association.

3.Meals, etc. - a per diem of \$35 for meals and incidentals.

APLA Bulletin Editor

The transition of editors from Judy Reade to Andrea John was achieved smoothly thanks to the newly written procedure manual and the recommendations written by the departing editor. Judy Reade's report to the Executive regarding how the *Bulletin* was published was reviewed by the Executive and the incoming editor. Many of these recommendations have been or will be implemented. Some of the recommendations require constitutional changes.

In January, a new publisher was selected following the closure of Dartmouth Free Press' typesetting department. The new publisher is PageCraft of Halifax. The new publisher produces a more attractive product, offers a streamlined production schedule and process. The transition to PageCraft has been made with no price increase over the

previous publisher.

The total for advertising revenue was \$2,284 with a range per issue between \$181.00 and \$716.00. During 1987-88 approximately 100 promotional letters were sent to various bookstores, vendors, publishers, etc. Only about four new advertisers were generated as a result. Revenue fluctuations generally represent more or fewer job advertisements in any one issue. With the new look of the *Bulletin* came a new rate card redesigned by Andrea John and Laura Jantek. This is now photocopied on heavier stock paper.

There were 101 paid subscriptions to the Bulletin. This figure does not include personal, institutional and complimentary copies distributed. The total circulation figure for each issue of the Bulletin is approximately 600.

The Library Boards Association of Nova Scotia held quarterly meetings in 1987-1988 dealing with issues relating to libraries and trustees. The formula is based on population and uniform assessment, and provincial monies are paid directly to library boards. The formula is a great step forward in attempting to equalize funding across the province.

President Higgins attended CLA executive meetings and the CLA Conference in Vancouver, June 1987. Vice-President Kirincich attended APLA in Saint John, New Brunswick and also NSLA Conference in Bridgewater, Nova Scotia. Past President Himmel-

man also represented LBANS at the Bridgewater Conference.



Membership Report

Committee on Intellectual Freedom

A new member of the Committee is Moira Davidson, Mount Allison University, New Brunswick.

Halifax City Regional Library celebrated Freedom to Read Week with a panel discussion, an information table, and a Freedom to Read Week pamphlet.

On February 24, Alan Borovoy of the Canadian Civil Liberties Association was keynote speaker at a panel discussion on the proposed Bill C-54. Mr. Borovoy, who opposes the bill, mentioned its possible implications for libraries, and pointed out that the effect of the legislation may differ substantially from its intent.

Panelist Francene Cosman spoke in favour of the bill, while Donna Smyth and Lorenne Clark opposed it.

A capacity audience vigorously contested or supported the views of the various panelists.

On February 23, the Writers Federation of Nova Scotia staffed an information table in the lobby of the Main Library. Authors Joyce Barkhouse, Silver Donald Cameron, Nancie Erhard, Tony Foster, T. H. Hatte, Elizabeth Jones, Donalee Moulton-Barrett, Phil Roberts, and Paul Robinson participated. ATV sent a camera team, and a news clip showed library patrons signing postcards asking for the withdrawal of Bill C-54

A display of banned or challenged books was mounted at each library outlet.

The library's Freedom to Read Week pamphlet excerpted the C.L.A. Statement on Intellectual Freedom, outlined the purpose of Freedom to Read Week, quoted Canadian writers on Bill C-54, and explained how to read up on the issue using library resources.

The centerfold listed the library's holdings of works by authors who took park in the information table.

The Halifax City Regional Library Board received a letter back from Hon. R. J. Hnatyshyn in which he continues to support Bill C-54. APLA Joy Tillotson has received a reply back as well and the content of his letter is similar to the one received by the Halifax Board.

In Newfoundland, the St. John's Public Library and Memorial University Library supported Freedom to Read

Week by posters and displays of banned books. At the Grand Falls Central Community College, postcards against Bill C-54 were handed out, and posters were displayed during Freedom-to-Read-

In Prince Edward Island, Judy Blakney relates that letters of protest concerning Bill C-54 were sent to all provincial MLA's from the Prince Edward Island Professional Libraries Association. Judy sent out the postcards against Bill C-54 to all the Branch Libraries of the Provincial Library System, and interested users sent them to the federal government in Ottawa.

The Nova Scotia South Shore Regional Library Board in Bridgewater sent in a letter of protest concerning Bill C-54 and urged that it be withdrawn.

Pierre Berton sums up very well in his statement on Bill C-54 the concerns of those who believe in intellectual freedom in Canada as one of the fundamental civic rights in a democracy. "The new bill hamstrings all writers. It is censorship pure and simple. It is also ambiguous. We can no longer 'incite, promote, encourage or advocate' what the bill, vaguely calls 'sexually degrading acts' whatever these may be. In short we are being transported back to the Nine-teenth Century by a government who, using the red herring of 'kiddie porn' (which is far, far underground and will stay there), is about to make us the laughing stock of the western world." New Brunswick

University of New Brunswick

Funding from the Canada/New Brunswick Subsidiary Agreement on Industrial Innovation and Technology Development totalling \$57,353 has been awarded to the University of New Brunswick's Science and Forestry Library for an information transfer proj-The recent announcement was made by Robert Howie, M.P. for York/ Sudbury, and Al Lacey, New Brunswick Minister of Commerce and Technology, on behalf of the Atlantic Canada Oppor-

tunities Agency. The project is being implemented by Mark Leggott in conjunction with Eszter Schwenke and will extend up-to-the-minute computerized reference services to professionals in industry and the private sector.

Saint John Regional Library Sussex Public Library held a book fair for the local chapter of Canadian Parents for French on April 8th and 9th.

Campobello Public Library held an open house on Saturday, April 16 to unveil the completion of their first phase of project restoration.

Chaleur Regional Library

An ad hoc committee set up by the Chaleur Regional Library Board "to study the possibility of finding more adequate space for the regional office" presently located in Campbellton, has come up with the following recommen-

 that the Chaleur Regional Library move its headquarters into more adequate space in a more central location,

· that the subheadquarters of the Chaleur Region be established in Campbellton with a minimum of four employees in order to provide adequate service to the libraries in the western part of the region and to supervise the establishment of new libraries which will open in the future.

After the Regional Board accepted the report in its entirety, it was presented to the Minister of Tourism. Recreation and Heritage, Roland Beauileu. A decision is expected by the end of May, 1988.

York Regional Library
Muriel Morton, a librarian with the Saskatoon Public Library, has been appointed by the York Regional Library Board to head the Oromocto Public Library.

Fredericton Public Library par-

ticipated with local art galleries and libraries in mounting a series of displays of book and paintings that could be "endangered" if Bill C-54 becomes law. Held from March 20 to 26, exhibitions were held at the Beaverbrook Art Gallery, The University of New Brunswick Art Centre, and Gallery Connexion, as well as at the city library and UNB's Harriet Irving Library. A reading was also presented by the New Brunswick's Writer's Federation. The week-long program generated a great deal of public and media interest.

The compact disc collection of the Fredericton Public Library passed the 500 disc mark in February, under the direction of librarian Greg Blake. CDs have met with a tremendous response since being introduced at the library in December of 1985. Circulation is now more than 1000 per month, despite a limitation of two discs per patron - a limit enforced by an automated checkout system. Even with this restriction, more than 90 per cent of the collection is out at any one time. Cassettes are still the main focus of the music collection, but it is interesting to note that CDs will soon account for 20 per cent of the 65,000 and over annual circulation, even though they are outnumbered 20 to 1.

Damage and loss have been negligible. The first discs purchased have had more than fifty circulations and still sound as good as new. Feedback from the public has been very positive. Twenty-five CDs have been donated to the collection — nine from one patron alone. All told, CDs have been an excellent addition to the music library.

Nova Scotia

The NSLA Board of Directors Meeting was held recently at the Pictou-Antigonish Regional Library. Many items were discussed at the March 11th meeting with most emphasis being placed on preparation for Nova Scotia Library Association Day at the 1988 Canadian Library Association Conference. This event will take place on Thursday, June 16th beginning at 1:30 PM.

This summer's reorganization of Acadia's Vaughan Library must be orchestrated around completion of the new expansion and renovations of the existing building. One problem the library faced was the moving of 18,000 shelves of books and journals from one floor to another, at astronomical costs (\$900 per day for rental of various conveyances). So Library Assistant Susan Lyons come up with an idea for a "book stack on wheels".


Acadia's Physical Plant staff took Susan's sketches, and after several modifications, produced a vehicle

which was pronounced the perfect solution. Christened "Cruisin' Susan" by library staff, the cart is made out of obsolete shelving. The library now has twenty Cruisin' Susans. Though light and small enough to fit in the Library's elevator, each is capable of moving 35 feet of books in one trip. The average cost is \$200 including materials, labour and time to produce and modify the first three prototypes.

The Faculty of Library and Information Science, University of Toronto, is introducing a new program in Information Science in September 1988. The 12 month program leading to the Master of Information Science (MIS) degree concentrates on the nature of information and the ways it is created, managed and accessed, especially using computer technology.
