




It is so nice to feel the weather getting warmer and see the days getting longer. I hope that you've all had a lovely Spring and have some upcoming Summer plans!




Looking Forward: Library Futures

Erica Friesen, Research and Instruction Librarian (Law) & Online Learning Specialist at the William R. Lederman Law Library at Queen's University.



We know there is no shortage of very worthy candidates, and we encourage everyone to put forth names of those you believe would be ideal for these feature stories.



Innovative Lending: Enhancing Tool Access at UNB's Engineering and Computer Science Library with Google Lens


Introduction

Traditionally, libraries have provided information services where patrons can borrow books, journals, magazines, newspapers, and more in various formats to meet their informational needs. However, in recent years, many academic, public, and special libraries have begun offering more "non-traditional" items and services, reflecting a growing trend as more people participate in shared economies. Non-traditional library items typically refer to tools, equipment, and devices that patrons can borrow, in addition to the traditional informational materials and services.

There are generally two types of libraries that offer these services: those dedicated entirely to non-traditional items, such as the Toronto Tool Library, The Kitchen Library, and the Calgary Tools Library, and traditional libraries that provide non-traditional services in addition to their primary mandate of informational services. The Engineering and Computer Science Library at the University of New Brunswick (UNB) adopts the latter approach. This article will discuss the new and exciting non-traditional materials introduced at the Engineering and Computer Science Library and how they are being used and perceived by our students, faculty, and staff.

Non-Traditional Material at Our Library

As the name suggests, the Engineering and Computer Science Library serves both the Engineering and Computer Science faculties at the University of New Brunswick, Fredericton campus. Our patrons include students, faculty, staff, alumni, and occasionally the general public. In terms of physical space, we are small, but in terms of door count and space use, we are, per capita (per square foot), the busiest library on campus at UNB. Our library has embraced the concept of non-traditional materials to meet the evolving needs of our community. These materials range from hand tools and power drills to other equipment and devices indispensable for both academic and personal projects.





Hand Tools and Power Drills

The "Tool Lending Service" at the Engineering and Computer Science Library allows students, faculty, and staff to borrow tools at no cost for three days. This service was introduced after informal conversations with local, interprovincial, and international students revealed a need for tool lending in libraries. Many new students lack the tools required to assemble, organize, and decorate their new university homes, whether a dormitory room, apartment, or house. The tools typically used by students to arrange their new settings are often expensive and fall outside a student budget since these items are seldom used.

Our tool library has been an integral resource for several years, continuously expanding to meet the growing needs of our patrons. Each year, we enhance our collection by adding new tools funded by the Engineering Program Fund (EPF). Initially, our library offered only hand tools, but we have since expanded to include a variety of power tools and additional equipment.

Our current collection includes hand tools such as screwdrivers, pliers, hammers, levels, tape measures, wrenches, hand saws, and drill bit sets. We also provide power tools, including drills, dremels, and sanders. Additionally, we offer essential equipment like ladders, portable workbenches, and a Jack and Axle Stand Kit.

This continuous improvement ensures that our tool library remains a valuable and versatile resource for all users, supporting a wide range of projects and fostering a culture of hands-on learning and innovation.

Introducing Google Lens

With the increasing use of power tools, it became essential to provide users with additional resources to ensure the safe and effective use of these tools. This is where Google Lens comes into play. Google Lens is a powerful image recognition technology developed by Google. It uses artificial intelligence to identify objects, landmarks, text, and other elements within an image captured by a smartphone camera. The application can provide information about the identified objects, translate text, recognize plants and animals, and even facilitate shopping by identifying products.

Integration and Benefits

Tool Identification and Information:

One of the primary benefits of Google Lens in our tool lending service is tool identification. By simply taking a picture of a tool, users can get information about its name, function, and proper usage. This is particularly helpful for those unfamiliar with certain tools or for international students who may not know the English terms for specific tools. Furthermore, Google Lens can quickly pull up user manuals, video tutorials, and safety guidelines, ensuring that users have all the information they need to use the tools safely and effectively.



Enhanced Inventory Management:

Google Lens also aids in inventory management. By scanning barcodes and QR codes on tools, staff can quickly access inventory records, check-out statuses, and other relevant data. This streamlines the process of tracking which tools are available, which are out on loan, and which need maintenance or replacement. Additionally, staff can use Google Lens to document the condition of tools before and after use, ensuring better maintenance and quicker identification of tools needing repair.

User Assistance:

For users who need immediate help with a tool, Google Lens provides on-the-spot assistance. If a user has trouble using a tool, they can use Google Lens to access how-to guides, troubleshooting tips, and instructional videos by photographing the tool. This reduces the need for library staff to provide inperson assistance, freeing up their time for other tasks. Google Lens can also help users identify each part of a complex tool, reducing the risk of improper use or assembly.

Educational Support:

Google Lens offers educational support by directing users to additional learning resources such as articles, videos, and courses related to the tools they are borrowing. This enhances the educational experience by providing more in-depth knowledge and practical tips. For international students and faculty, Google Lens can translate labels, instructions, and safety warnings on tools into their native language, ensuring comprehension and safe use.

Research and Innovation:

Google Lens can also stimulate research and innovation. By recognizing various tools and their uses, Google Lens can help users brainstorm and develop new ideas for projects. This can lead to more creative and innovative work, particularly in engineering and computer science disciplines. Additionally, users can use Google Lens to find academic papers, patents, and articles related to specific tools or technologies, aiding in research and citation.

Accessibility:

Accessibility is another significant benefit of Google Lens. For visually impaired users, Google Lens can provide audio descriptions of tools and their features, making the tool library more accessible to all users. This ensures that everyone, regardless of their physical abilities, can benefit from the tool lending service. Instead of manually searching through catalogs, users can use images to find tools, making the process faster and more intuitive.


Analysis

The integration of Google Lens into the Engineering and Computer Science Library's tool lending service represents a significant advancement in how non-traditional library materials can be managed and utilized. This technological enhancement addresses several key issues and opens up new possibilities for both library staff and users.

Efficiency and User Satisfaction:

The primary analysis revolves around the increased efficiency and user satisfaction resulting from

Google Lens integration. By providing immediate access to tool information, usage guides, and troubleshooting tips, Google Lens significantly reduces the time and effort required by users to learn how to use the tools properly. This leads to higher user satisfaction as they can quickly and easily find the information they need, making the tool lending experience more enjoyable and less frustrating.

Safety and Maintenance:

Safety and maintenance are critical aspects of lending power tools. Google Lens helps ensure that users are well-informed about safety procedures and correct usage, reducing the risk of accidents. Additionally, the ability to document the condition of tools before and after use helps in maintaining the tools, ensuring they are always in good working condition and safe to use. This proactive approach to maintenance can extend the lifespan of the tools and reduce replacement costs.

Educational Value:

From an educational perspective, Google Lens enhances the learning experience by providing additional resources and learning materials. This is particularly valuable in an academic setting where students and faculty are constantly engaged in research and practical projects. The ability to access related academic papers and patents can also contribute to the scholarly work of students and researchers, facilitating more in-depth studies and innovative projects.

Inclusivity and Accessibility:



The New Brunswick Bibliography Series is part of a larger project undertaken by UNB Libraries in 2016, to focus attention on New Brunswick authors and publications. The project encompasses related activities, including the digitization of print sources and the development of the *New Brunswick Bibliography Online*, the hosting of symposiums, and through an arrangement with Gaspereau Press—the publication of bibliographies and essays within the New Brunswick Bibliography Series.

The NBBS is projected to encompass not only 'lists of books' on diverse topics of social, political, and cultural importance to New Brunswick, but also aims to comprise volumes dedicated to all aspects of books and book history.

News from Memorial University Libraries

University News:



Dr. Patrick Gamsby published a piece titled 'On the Sociology of Boredom' in Sociology on the Rock:

Keep@Downsview Update: The first shipment of items from the QEII collection to the University of Toronto Libraries (UTL) preservation facility in Downsview occurred on April 18th. Included in that shipment, and representing much work on the part of staff in Acquisitions & Serials and Cataloguing & Metadata, were 14,410 journal volumes which were held by Memorial but not by UTL. The Keep@Downsview partners are building a shared single copy collection in Downsview. That collection is available to Memorial library users through document delivery.

The <u>Memorial University Research Repository</u> has been selected as an early adopter for a collaborative initiative lead by Scholars Portal to develop a national repository service infrastructure called Scholaris. Through participation in this initiative, the Reimagining the Research Repository strategic planning team will implement the recommendation to convert Memorial's research repository platform from EPrints to DSpace. Work will begin in September.

The Libraries recently acquired 451 digital Newfoundland and Labrador titles that we didn't have in that format. A few noteworthy titles: <u>Don't have your baby in the dory!</u>, <u>Come from Away : An Inside Look at the Hit Musical</u>, <u>Lament for an Ocean : The Collapse of the Atlantic Cod Fishery.</u>

Cathy Taylor has retired from LITS. We wish her all the best on her new adventures.



Congrats to QEII Library's **Don Walsh** who was inducted into the Order of Folk (a new initiative of the Canadian Folk Music Awards) on Friday, April 5th.

The Libraries' Archives and Special Collections hosted two successful events: **The Video Journey of Disability Rights Activists** – a celebration of a project by the **History of Disability Rights – NL** organization that is now on the DAI. It features a timeline of milestones in the disability movement, as





well as the oral histories of key activists. You can watch the videos here. And also Unboxing the history of social work in NL -- Dr. Donna Hardy Cox, Dr. Michelle Sullivan, and Colleen Quigley presented on an archival collection that was recently added to the Archives and Special Collections Division. This event highlighted the collaboration between the archives and the School of Social Work to document the important history of social work in the province.


The QEII addressed the growing need for more graduate student study space by piloting a project that involved revamping a space off the main Commons area. The space is a mix of study carrels, desks and soft seating. It is accessed by proxy card and designed for students who are in the intense study/writing period of their graduate program. The pilot will be assessed in August and fully implemented in the fall with any lessons learned.

The Valentine-making station was particularly popular with students, who were eager to make cards for their friends!

On March 8th, Grenfell hosted their Grenfell Authors event in celebration of International Women's Day, featuring female faculty members with recent book publications.





The area known as the Fiesta Deck in the QEII Library on the third floor has received an overhaul that includes fresh paint, new furniture, and some sound buffering panels. The project was done in conjunction with funding from the Office of the Associate Vice-President (Academic) Students.



May 5th is **Red Dress Day**, a day to honour the missing and murdered Indigenous women and girls and two-spirit people (MMIWG2S) of North America. It is a day to raise awareness and education about the disproportionate rates of violence and number of MMIWG2S. There was a display of red dresses in the QEII Library lobby from May 5th-10th led by **Michaela Doucette**.

The Archives and Special Collections Division has two student summer CO-OP students. **Caroline**

Boone, from the University of Toronto, will be working mostly with the map collection during her 12-week placement (May-August). **Ruva Mushati**, from the College of the North Atlantic's Records & Information Management program, will be interning for six weeks (May-June).

Archives and Special Collections' archivists **Colleen Quigley** and **Michaela Doucette** are headed to the Labrador Campus in Happy Valley Goose Bay from May 13-23 to work with the team there concerning archival materials.


Also from Archives and Special Collections - **Matthew Keels** and **David Mercer**, as part of the CLB Regimental Band, played at the funeral of legendary sports broadcaster **Bob Cole**.

Between April 1-8, the Grenfell library distributed 100 solar eclipse glasses, donated by the Office of Public Engagement, to students, advertising the glasses with a mini-display featuring books about the sun.

A bunch of enthusiastic primary/ elementary kids from St. Bon's were invited to the Education Library by faculty member **Dr. Jan Buley** to experience the book displays that were created for her Language Arts course. Roughly 50 school-aged children and teacher candidates read, sang and got very excited about lessons in Language Arts paired with Music.

The Labrador Campus hosted a night of fun and connection with their Adult Storytime program. CBC host **Rhivu Rashid** read *Aparichita*, by **Rabindranath Tagore**. The Bengali Nobel laureate poet wrote this story of starcrossed lovers in 1916, and Rhivu promised it would be as relevant today as ever — and it was. Rhivu grew up in Bangladesh and had always loved the story, and was excited to share it.







From April 1-5, the Grenfell Library ran "The Final Countdown Snackdown," to support students through the final week of classes, serving all-day free coffee and tea and a surprise snack every afternoon, including popcorn, cookies, and ice cream!



From March 22 – April 19, the Grenfell Library created a positive note station where students could take or leave a positive note to encourage themselves and others through the final weeks of the term.

Melissa Hefford of the Health Sciences Library did a display that featured current women in medicine at the Faculty of Medicine to honour International Women's Day.

The Labrador Campus Library celebrated spring with an open house and "Grand Opening" on March 20th. Librarian

Sarah Papple hosted the community in two events. The midday event highlighted local collections and invited people to explore with a scavenger hunt, and featured music from the Big Land. The evening was the first of their storytelling events with special guest **Mina Campbell**. Mina is a Labrador leader, artist, and source of story and information that many go to. 

As a result, the committee has created the **Small but Mighty** award, which recognizes excellence in summer library programming. Laura and Marilyn of the Bay Roberts Library will be the inaugural recipients of this national award, which was created as a result of their phenomenal work offering literacy programming to youth in their community. They will receive \$1,000 for their children's area in recognition of their hard work.



This year, the members of the jury were so impressed with what a very small library did with two part-time staff and zero budget that they wanted to reward them for offering such an incredible TD Summer Reading Club program. After much deliberation, the Small but Mighty Award was created. This award will only be given out in exceptional circumstances to very deserving libraries.

The Bay Roberts Library (Newfoundland and Labrador) blew the jury away with their approach to the Summer Reading Club. This small but mighty library came up with terrific reading challenges for young readers. The jury admired how playful they were with decorating onsite, using "scoops" of paper ice cream and a giant bookworm that grew with the number of books read. In the end, Miles the Bookworm was over 250 feet long (averaging 10 books/reader). The appearance of Logan the Newfoundland Dog at the Toutons, Tunes and a Tale! event also made a special impression on the jury. The clever and engaging "Get Caught Reading" virtual challenge—in which parents posted pictures of their kids reading at home, outdoors and around town—was a great way to motivate kids to read anywhere and at any time.

The jury would like to compliment, recognize and shine a spotlight on the Bay Roberts Library as a wonderful example of the inventive, effective and creative literary youth programming that is possible on a shoestring budget when produced by hearts full of literary passion.





We are so proud of the accomplishments of our staff in Bay Roberts, and that their hard work will recognize other small libraries in Canada.



Hours Restored at All CPL Locations

Due to ongoing financial difficulties, we made the difficult decision to reduce service hours at four of our seven library locations as of April 1, 2024.

However, thanks to the amazing support of local representatives, hours have been restored at all of our locations! The Municipality of Cumberland, along with the Towns of Amherst and Oxford, have agreed to provide one time bridge funding in the amount of \$67,335 for the 2024/25 fiscal year. This bridge funding offsets our project deficit.

Hours restoration would not have been possible without the dedication of our Municipal and Town Councilors, Mayors **David Kogon**, **Murray Scott**, and **Greg Henley**, and the countless members of their staff. They have shown that Cumberland County deserves sustainable and affordable core library services in the region.

Read Local Cumberland Starts on May 24!




Within the library, we are supporting patrons by providing snacks at our seven locations. We have also installed a food pantry in our Amherst location.



Job searching and creating an effective resume is another service that patrons value. Career Development Services partnered with PEI Public Library Service to offer one-on-one sessions to help update resumes.





Along with other provincial VPs, recipients were chosen for the Carin Alma E. Somers Scholarship and the APLA Merit Award.



Initiatives



APLA Financial Records Update from Peter Glenister

To the members of the Atlantic Provinces Library Association,

I have examined for integrity and accuracy the financial records of the Atlantic Provinces Library Association as at 31 March, 2024, including the statements of operations, functional expenses, changes in fund balances and changes in financial position for the year then ended. My examination was conducted by applying risk assessment standards for not-for-profit organizations and, accordingly, included such tests and procedures as I considered necessary in the circumstances. In preparation for my review of the Association's records I corresponded with the Treasurer to receive the necessary documents and to clarify certain points.

In my opinion the Statement of Revenues and Expenditures and balance Statement represent fairly the financial position of the organization and its investments as at 31 March, 2024, and the results of its operations and the changes in its financial position for the year then ended, in accordance with the notes to the Statement, have been applied on a basis consistent with that of preceding years. As of that date, the aggregate of assets is \$163,659.35 and the Association's equity is \$164,215.31.


I included in my examination, in accord with Standing Order 3.10, the Carin Alma E. Somers Scholarship Fund and, in my opinion, the Statement of Revenues and Expenditures and the balance Statement represent fairly the financial position of the Fund as at 31 December, 2023. The equity of the Somers Fund was \$82,662193 as of 31 December, 2023.

Also in accord with Standing Order 3.10, I have examined the financial records of the APLA Memorial Awards Trust Fund and, in my opinion, the Statement of Revenues and Expenditures and the balance Statement represent fairly the financial position of the Trust Fund as at 31 December, 2023. The current value of the Fund is \$53,072.19 although the Balance report gives \$53,125.36 because the interest paid in January 2024 has been inadvertently included.

At the discretion of the Executive, Standing Order 3.09 directs that up to \$1,000 of any annual operating surplus may be transferred to the Memorial Awards Trust Fund and Standing Order 3.15 that 50% of any annual conference surplus be divided between the Memorial Awards Trust Fund and the First Timers Conference Grant. These transfers were made during the fiscal year.

Implementation of the Quick Books software for managing the Association's accounts continues to be of enormous assistal1'Ce for the Financial Examiner as it is certainly for the Treasurer.

The Information Literacy Interest Group has been active with its two main projects: bi-monthly emails on information literacy related topics, and virtual drop in learning spaces.




APLA Bulletin Report May 2024 Kate McClintock




The committee met on Tuesday, April 23, 2024, at 8:30 am, to review the application for the Memorial Award. We unanimously decided to give the award (\$800) to Grace Bourret, Kaitlin Fuller, and their team of four other librarians. The group will conduct a study called, *Measuring the Impacts of Play in the Academic Library: A Cross-Sectional Study*.

The goal of the proposed project is to measure the impact of play on student outcomes using a cross-sectional study. We're specifically looking to measure:

- 1) enjoyment of the event,
- 2) satisfaction with the library, and
- 3) sense of belonging within the campus community

The committee is interested in the study We're excited to learn the results of this study. We're happy the Bourret/Fuller group has a detailed plan to share the results at a library assessment conference such as the Library Assessment Conference in November 2024, and at the APLA Conference in 2025. The group intends to upload their programming and to publish the results of their study.

The lessons learned will be useful to many libraries (school, public, and academic) as every library is looking for greater engagement. We think the results of this study will be useful to the Games Convener. Perhaps a collaboration between the applicants and Games could happen in the future.





Memorial Award Committee Goals

- 1. Become more active throughout the year in promoting the award.
- 2. Advertise the work of the winners.
- 3. Promote collaboration between committees, Atlantic library staff, and associations.

Next Steps

The committee will meet with Nathalie Richard, in June, to discuss the role the committee could take in social media promotion. The committee will then solidify our plans for the fall. We plan to meet with Nathalie's successor, in September, to continue the conversation and implement our plan.

API A Event Code of Conduct

Introduction

The Atlantic Provinces Library Association (APLA) is proud of the professional development that occurs each year during the APLA Conference. APLA's mission is to promote the interests of libraries in the Atlantic Provinces while fostering the development of librarians, library technicians, and information professionals through cooperative efforts and the promotion of library interests.

APLA is dedicated to providing a positive event experience for all participants and expects attendees, speakers, exhibitors, volunteers, and staff to show respect and courtesy toward one another at all conference and conference--- related events. We value ideas, thoughts and expression, and we appreciate new pedagogy when delivering workshops and sessions. Discriminatory language and imagery is not appropriate for any event venue, including talks, workshops, sessions, or any community event online or in a face---to---face environment.

Purpose

We do not tolerate harassment in any form. Harassment is understood as any behaviour that threatens another person or group, or produces an unsafe environment. It includes offensive verbal comments or non--- verbal expressions related to gender, gender identity, gender expression, sexual orientation, disability, physical appearance, body size, race, age, religious beliefs, sexual or discriminatory images in public spaces (including online), deliberate intimidation, stalking, following, harassing photography or recording, sustained disruption of talks or other events, inappropriate physical contact, and unwelcome sexual attention.

Participants asked to stop any harassing behaviour are expected to comply immediately. If a participant engages in harassing behaviour, the conference organizers may take any action they deem appropriate, including warning the offender or expulsion from the conference with no refund. We expect participants to follow these rules at conference and workshop venues and conference-related social events.

Procedures

If you are being harassed, notice that someone else is being harassed, or believe that this code of conduct has been breached in any way, please contact a member of the conference staff immediately. Conference staff will be identified at the beginning of each session and will be located




at the conference registration desk. If you believe someone is in physical danger, please notify appropriate law enforcement first.

Conference staff will be able to help participants contact hotel/venue security or local law enforcement, provide escorts, or otherwise assist those experiencing harassment to feel safe for the duration of the conference.

Conference Staff Procedure for Handling Harassment Reports


- o If there is a general threat to attendees or the safety of anyone is in doubt, summon hotel/venue security or police immediately.
- o If an incident is reported that does not pose an immediate threat, gather the following information about the incident:
 - Name of participant doing the harassing
 - o Names of other people involved in the incident
 - Behaviour that was in violation
 - o Approximate time of the behaviour
 - o Circumstances surrounding the incident
- If an incident is reported to conference staff, meet with the conference chair and/or event coordinator to determine whether action is required. Possible actions that may be required include:
 - Informing the alleged harasser of what has been reported and allowing him/her to provide their side of the story;
 - Warning the harasser to cease the behaviour;
 - Requiring that the harasser avoid any interaction with and/or physical proximity to the victim for the remainder of the event;
 - Ending a talk early that violates the code of conduct;
 - Not publishing the video or slides of a talk that violated the code of conduct;
 - Not allowing a speaker who violated the code of conduct to give further talks at the event or future APLA events;
 - Immediately ending any event responsibilities or privileges the harasser holds;
 - Requiring that the harasser not participate in future APLA events;
 - o Requiring that the harasser immediately leave the event and not return;
 - o Removing the harasser from APLA membership.
- Only permanent resolutions, such as bans, may be appealed. To appeal a decision, send an





email to the current APLA President. Contact information can be found at APLA Contact Us.

*This Event Code of Conduct was accepted by the membership at the OGM 2017 in Charlottetown, and reaffirmed at the OGM 2018 in Fredericton.
